A letter from the Headteacher and Chair of Governors.

Dear Parents and carers,

Over the past week, the Governing Body and school leaders have met virtually on three separate occasions to discuss and review the plans to reopen the school. We believe that both the risk assessments, alongside the strategic and opening plans are robust and provide clear guidance on how the school is addressing the following factors:

 The measures that can be implemented in the school to minimise contact and mixing of pupils and staff – such as organising classes in small groups of 15 or less, maintaining space between seats and desks where possible, using the timetable and selection of classroom or other learning environment to reduce movement around the school or building (staggering the school day), parents' drop-off and pick-up

- protocols, and avoiding staff working with more than one group of pupils wherever possible.
- The procedures that the school is able to put in place to ensure good hygiene practices such as sufficient handwashing facilities, availability of hand sanitisers provided in classrooms and other learning environments, clearly communicated hygiene protocols and the support for children and staff to implement them.
- The procedures that the school is able to put in place to ensure
 adequate and regular cleaning how they comply with COVID-19:
 cleaning of non-healthcare settings guidance, surfaces being cleaned
 more regularly than normal and communication with contractors and
 suppliers that will need to prepare to support the school's plan to
 increase the number of pupils.
- The measures that the school is able to take that minimise the risk of
 contact with anyone with COVID-19 symptoms such as
 communicating with children, parents, carers and any visitors, such as
 suppliers, not to enter the school if they are displaying any symptoms
 and ensuring that transport providers do not work if they or a
 member of their household are displaying any symptoms of
 coronavirus.
- Additional measures put in place to protect staff and pupils, including those with underlying health issues, staff who are within at risk categories, and those who are shielding.

We look forward to welcoming pupils back from the 8th June. The phased reintroduction is as follows:

• 08 June: Year 1 and Year 6 return

• 15 June: Reception pupils return

• 18 June: Nursery reopens

The school will be open to pupils in N, R Y1 and Y6 on Mondays, Tuesdays, Thursdays and Fridays. School will be CLOSED on Wednesday. Key workers and vulnerable families will have access to the site for the entire week, including Wednesdays.

The school is also aware that many children will not be able to return to school due to the fact they are either in Y2,3 4 & 5, or self-isolating due to parental concerns or pre-existing conditions. Ryefield has purchased additional English and Maths workbooks for the children whose classes cannot return to school, alongside a staggered roll-out of enhanced distance learning. This will involve the use of Google Classroom, Wonde, your child's emoji login and much, much more. Training and support materials will follow.

Both the school and the Governing Body would urge you to read the information available on the school website. For those of you returning to school we request that you discuss it with those closest to you, and follow your parental instinct.


Teachers

Absence

The school will continue to follow its attendance policy. Absences will be followed up by email and we encourage parents to notify us if their child is unwell.

School spaces



Core message

In order to maximise the space available to your children, pupils will be located in the following areas.

EYFS

The EYFS will have use of the Nursery, Sapphire class, Topaz Class, Coral class, as well the outdoor space, small field and the Forest School Area.

These areas will be timetabled to ensure each 'bubble' does not interact with each other.

Y1 & Y6

Y1 will have use of Amber, Amethyst, Emerald and Jade class. Y6 will have the use of Churchill, Curie, Faraday and Mandela class.

Playtimes will be scheduled to ensure 'bubbles' do not interact with each other.

KWVP

KWVP provision will be accessed via the Community Room and the children will be sorted by age groups. They will have access to the community room, KS1 hall, KS2 hall, middle playground and the ICT suite.





Break & Lunch



Core message

The school kitchen will not be preparing any hot meals for the remainder of the academic year. Lunches will be ordered as normal via Parent Pay. All lunches will be eaten either in the classroom or on the school field. Rubbish will be taken home.

EYFS

We do not recommend pupils bringing a mid-day snack as this may increase the risk of transmission.

FSM

Families who are eligible for Free School Meals will receive a packed lunch (which can be ordered via Parent Pay) in place of the voucher system. Families of FSM pupils who are not attending school will continue to receive vouchers for as long as the government scheme continues.

In order to ensure that the school is able to operate in a safe and secure fashion, we require parents and pupils to sign and agree to upholding the new Home / School agreement.

School

The school agrees to work to the best of its ability to provide an environment which promotes social distancing and good hand hygiene.

Clear guidelines are in place to control the spread of infection and pupils displaying symptoms will be isolated and sent home.

Parent

Parents will adhere to the school's guidelines and will not send their child to school if they are unwell and display C-19 symptoms.

Parents will ensure they observe social distancing and follow the school's drop off and collection times.

Pupil


Pupils will follow their teacher's instructions. They will maintain social distancing rules and continue to follow good hand hygiene rules.

Social Distancing



Core message

The Governing Body has determined that the school's current arrangements will have -to the best of our ability - a safe level of occupation. Resources and timetables have been altered to facilitate social distancing.

School

The school will only take pupils from N, R Y1 & Y6, alongside KWVP, and classes have been capped at 15 pupils.

Timetables and routines have been adjusted or canceled to maintain social distancing.

Parent

Parents will support the school's efforts to enforce social distancing measures.

This will require parents to demonstrate that behaviour themselves, and discuss strategies with their children. Pupil

Pupils will follow the school rules and maintain social distancing in school. This can be tricky for very young pupils.

Pupils will ensure that they remain in their learning space, whether that will be a table or an activity in the EYFS.





Infection Control



Core message

The school seeks to promote a healthy environment by establishing practices that reduce the risk of infection or accident by following standard infection control precautions (SICP).

Parent

Parent's have a responsibility to ensure they check their children for symptoms of C-19 before sending their child to school.

Pupil

Pupils will not attend school if they feel unwell and show symptoms for C-19. They will follow their teachers instructions and remain in their learning space/bubble. Pupils will wash their hands regularly and ensure - when coughing or sneezing -they 'catch it, bin it, kill it'.
